**General Terms and Conditions**

1. The Bidders may inspect the old Generator on a pre-determined date and satisfy themselves about the old Generator they are bidding for.
2. The old Generator will be sold to the highest bidder. However, the final decision would rest with Embassy of India, Baghdad and Embassy would owe no explanation to anyone about the selection process of the company/individual for the job
3. No items, once disposed to the successful bidder, shall be taken back by the Embassy, on any condition whatsoever.
4. The successful bidder must make full payment in the form of cash/cheque/bank transfer to the Embassy within 7 working days after confirmation.
5. The successful bidder shall be required to take away the Generator from the disposal site (without causing any damage to Embassy's property) on his own within 7 days of payment of bid amount.
6. All expenses will be borne by the bidder to take away all items from the Embassy premises.

**Terms and Conditions for Quotations**

1. The quotation letter in sealed envelope should be addressed to the Head of Chancery, Embassy of India, Baghdad, House No. 22, Street No. 16, District. 609, Al-Mahsour, Baghdad (Iraq).
2. The quotation must reach the addressee on or before the due date otherwise it is liable to be rejected. Bids received after due date and time due to any reason whatsoever including postal/courier delays shall not be considered.
3. The Financial bid should be quoted both in figures and words.
4. Embassy reserves the right to accept or reject any/all quotations without assigning any reasons whatsoever.
5. Each page of the bid should be signed by the bidder.
6. Incomplete and unsigned bids are liable to be rejected.
7. For Financial evaluation, the highest bidder shall be chosen based on the figures quoted.
8. The quotation should include Name, Mobile Number, Email and address details of the bidder. A copy of local Government ID should be enclosed along with the submitted quotation.
9. The successful bidder shall have to enter into a non-disclosure agreement with this office.
